All businesses that collect sales tax must submit a copy of their State license showing that the business is registered to collect tax inside the city limits of Westphalia. Section 144.083.2 RSMo, 'The possession of a retail sales license and a statement from the Department of Revenue that the licensee owes no tax due under sections 144.010 to 144.510 or sections 143.191 to 143.261, RSMo., shall be a prerequisite to the issuance or renewal of any city or county occupation license or any state license which is required for conducting any business where goods are sold at retail." <u>Osage County Business/Merchants License</u>. Business owners are required by §150.100 RSMo., 2000, to have a county Merchant's License if the Missouri Department of Revenue issues your business a State Sales Tax Number. This is the ONLY prerequisite for obtaining the county license.

<u>Health Inspection Report</u> issued by the Osage County Department of Health for any business that requires a Health Inspection Report, such as food service, hotel and lodging, childcare, etc.
