State of Missouri Business/Merchants/Retail Sales License and Missouri Department of Revenue No Tax Due Statement (2 separate documents). All businesses that collect sales tax must submit a copy of their State license showing that the business is registered to collect tax inside the city limits of Westphalia. Section 144.083.2 RSMo., "The possession of a retail sales license and a statement from the Department of Revenue that the licensee owes no tax due under sections 144.010 to 144.510 or sections 143.191 to 143.261, RSMo., shall be a prerequisite to the issuance or renewal of any city or county occupation license or any state license which is required for conducting any business where goods are sold at retail."
